This release, discharge and covenant not to sue shall relate to any and all claims or legal rights now existing or arising in future, including claims and legal rights arising out of any alleged negligence of 'Baccha Party Powai' and /or its managers, members, employees and/or other agents and any other breach of a legal duty arising out of common law, statute, contract or otherwise.
